SUBJECT: Industry Certification – Additional FTE in the 2013-14 Florida Education Finance

Program, Fourth Calculation

The Florida Education Finance Program (FEFP) includes additional full-time equivalent (FTE) membership in the calculation for students who earn industry certifications in career and professional academies or career-themed courses. The Florida Department of Education has completed the FEFP fourth calculation. This calculation is based on data submitted by districts through 2012-13.

The department's management information systems (MIS) staff have created student level reports which your district MIS staff may access. It is important to note that unlike previous reporting years, these reports produced for the 2013-14 FEFP fourth calculation are <u>cumulative for the entire year</u> and replace the reports produced for the 2013-14 FEFP third calculation.
