SUBJECT: Approval of New Rule 6A-10.0240, Florida Administrative Code, Minimum

Standards for Out-of-State High School Equivalency Diplomas

On August 18, 2021, the State Board of Education approved Rule 6A-10.0240, Florida Administrative Code, Minimum Standards for Out-of-State High School Equivalency Diplomas. The rule establishes minimum standards for a high school equivalency diploma issued by a state other than Florida for the purpose of admission to an associate degree program at Florida College System institutions. A copy of the rule is attached for your reference.

In 2021, Senate Bill 366 (Chapter No. 2021-162, Laws of Florida) amended section 1007.263, Florida Statutes, revising the requirements for admission to associate degree programs. To implement the new requirement, the rule recognizes state-issued high school equivalency diplomas based on a student achieving a passing score on the High School Equivalency Test (HiSET), the Test Assessing Secondary Completion (TASC) or the California High School Proficiency Exam, or based on a student achieving a combination of passing scores on HiSET, TASC or GED® subtests.

To assist institutions in implementing the provisions, attached are responses to several implementation questions that emerged during rule development. Each college should review the statutory and rule requirements and update their existing admissions policies and procedures to comply with the provisions. This may include updating institutional catalogs and websites, informing admissions advisors and modifying reporting mechanisms. More information regarding state reporting will be transmitted to reports coordinators as soon as practicable.
