## 2020-21 Florida's Optional Innovative Reopening Plan

### Purpose

The purpose of this document is to support districts in the development and submission of their Innovative Reopening Plan for the Department's consideration for the Fall 2020 school semester. This document will assist districts in aligning their existing plan with required assurances, or serve as the actual template for districts without an aligned plan to develop and submit one based on the assurances outlined in DOE ORDER NO. 2020-EO-06.

### Directions

The subject line of the email must include **[District Name] Innovative Reopening Plan**. The district has **two options** in the submission of an Innovative Reopening Plan:

MyPCS Online is the Pinellas County Schools' (PCS) Innovative Reopening option that allows parents and students to select full-time digital learning for the first nine-weeks of the 2020-21 school year. MyPCS Online allows students to remain enrolled in their assigned school and district application program while also allowing for all instruction to be delivered virtually, following a daily schedule (live-lessons each day), aligned to the district board-approved student calendar and bell times. This learning option is available for all students in grades K-12, utilizes the PCS curriculum and ensures daily lessons are developed and taught by PCS teachers. The curriculum and activities for students selecting MyPCS Online will be accessed via Canvas Learning Management System with class meetings and/or live-lessons utilizing Microsoft Teams for student and teacher interactions. Students and teachers are expected to be present and engage in virtual instruction each day within the designated schedule. Students who receive ESE, English Learner (EL) or Gifted services or have a 504 plan and select MyPCS Online will continue to receive their services. Families will be contacted to discuss how services, accommodations and supports will be provided through virtual learning. Assessments and progress monitoring will follow the board-approved assessment calendar. Should a student not find success in the MyPCS Online learning option, families can work with school leaders to transition in to the traditional learning option.
