STUDENT DEMOGRAPHIC – REJECT RULES

 **38. If Migrant Status Term is B, D, E, S, T, U, V, W or X, then Qualifying Arrival Date (QAD) for Migrant Program Eligibility must be greater than or equal to 9/1/2014 and less than or equal to 08/31/2018. (This edit does not apply to Survey Periods 6 and 8.) - record rejected-**

EXAMPLE

The first record would be rejected because the Qualifying Arrival Date (QAD) for Migrant Program Eligibility is not less than or equal to 8/31/2018. The second and third records would be loaded to the database assuming no other reject rule would cause their rejection.
