## Public Schools Administrative and Instructional Staff Terminations Database

In accordance with Section 1012.21(2)(a)(b), Florida Statutes, concerning the "Computer database containing the names of persons whose employment is terminated.... Each district school superintendent shall report to the Department of Education the name of any person terminated under s. 1012.33(1)(a) or (4)(c) within 10 working days after the date of final action by the district school board on the termination." This is a reminder to all public school districts that the staff terminations database is current and active and should be used to continue to adhere to the requirements of the statute. # Advanced International Certificate of Education (AICE) Exam Reporting

Districts are to report the AICE test information during the Survey 5 reporting period. Submit student assessment records for students who took one or more AICE exams during the school year. The Test Name code for this exam is CAI. This data will be used this fall in the calculation of high school grades under the high school grading system. #### **District Virtual Instruction and Virtual Franchise Student Data**

During 2009-10 Survey 4, school districts are to report database records for those students who were enrolled and instructed in District Virtual Instructional Programs (school number 7001) and/or District Franchise Programs (school number 7004). There are four formats to be reported: Student Demographic Information, Student Course Schedule, Teacher Course, and Exceptional Student. For more specific instructions, please see Appendix E in the 2009-10 FTE General Instructions found at the following link:

For the 2010-11 school year, any district that serves as its own virtual instruction provider must provide this information to the department so that the district may be listed in Appendix CC of the student database manuals. For the student records to load, the Virtual Instruction Provider data element must be coded with a provider listed in Appendix CC. Please report your intent to serve as a 2010-11 school district virtual instruction provider to Linda H. Fleming at <u>linda.fleming@fldoe.org</u> as soon as possible.

## **Summer Reporting Reminders**

- Remember to report in surveys 1 and 4 all courses taken by students in Department of Juvenile Justice (DJJ) schools.
- Districts are required to provide summer reading remediation to certain Grade 3 students. This instruction must be reported in surveys 1 and 4.
- For FTE purposes in surveys 1 and 4, the district should report classes that are conducted during survey week using the standard survey week dates for establishing membership and attendance. The district should choose the middle week/day of the class for classes that are conducted outside of the standard survey week period and use this middle week/day to establish membership and attendance for these classes.
- Report all summer instruction occurring prior to July 1 in survey 4 and all summer instruction occurring on and after July 1 in survey 1.
