## Exit Interview Survey and Data Collection

Section 1003.21, Florida Statutes, requires that an exit interview be conducted by a student's guidance counselor or other school personnel when a student has filed a formal declaration of intent to terminate school enrollment. In the 2009-10 school year there are four data elements designed to capture the information students provide in the Exit Interview Student Survey. The four data elements are reported on the Student End of Year Status record, and they are:

• Dropout Prevention: Primary Reason for Dropping Out

• Dropout Prevention: Secondary Reason for Dropping Out

• Dropout Prevention: Possible Influences

• Dropout Prevention: Actions Taken (new data element in 2009-10)

District student database staff should coordinate data entry and data quality assurance activities with the staff that collect and input these data. #### Reminder to District MSID Contacts

For 2009-10 districts are required to establish a School District Virtual Instruction Program. The school number 7001 should be used for this school. If your district has not already sent in a Master School Identification (MSID) application form for school 7001, please do so. This will allow us to make this school active for 2009-10. The MSID application form should be e-mailed to <a href="mailto:Rhonda.Forbes@fldoe.org">Rhonda.Forbes@fldoe.org</a> as soon possible.

Also, if your district plans to operate a Florida Virtual School Franchise (7004), please complete an MSID application form for this school and e-mail it to Rhonda Forbes.

# Staff E-mail Address Data Collection for the 2009-10 School Year

In accordance with Section 1012.05(3)(b), Florida Statutes, "By September 15 and February 15 of each year, each school district shall electronically submit accurate public school einstructional addresses for all administrative personnel, identified as s.1012.01(2) and (3), to the Department of Education." The submission period for the September 15 data collection is from August 20, 2009, to September 15, 2009. For further details, please refer to the e-mail notification dated August 20, 2009, sent to district MIS Directors and MIS and Staff Database Contacts.

### McKay Payment Files

The new 2009-10 McKay Prepayment Verification file submission (Survey A) was a success, and the data was used to verify payments to 19,969 students. Coming in mid-September are the McKay Payment Files which contain records for students that school districts should report in Survey 2. The format and manner of distribution of these files remain the same as in previous years. Districts will be notified by e-mail when the McKay Payment files are available to download.

## Reminder: Immigrant Student Data Element

A recent change has been made to the Immigrant Student data element definition for 2009-10 as per federal requirements. Please pay special attention to this change.

## Fall 2009 Public Schools Staff Survey – New Hires Data Collection

An e-mail notification announcing the Fall 2009 New Hires data collection survey was sent to District Personnel Directors on August 25, 2009. This is a multipurpose data collection instrument designed to collect data to meet state reporting requirements. Comprehensive data are used in the department publications *Critical Teacher Shortage Areas* and *New Hires in Florida Public Schools*. This data collection activity is specific to staff hired between July 1, 2009, and October 1, 2009. The completed survey should be returned by **October 30, 2009**.
