Education Information Portal

The Florida Department of Education has a new tool for school districts and the public to use to view and analyze education data. The Florida PK-20 Education Information Portal (EDStats) is available at this link: https://edstats.fldoe.org/SASPortal/public. This site includes graphs, tables, maps, and custom reports from PK-12 schools, colleges, and workforce data. The PK-12 Public Schools tile currently has interactive reports available for enrollment data, high school graduation rates, dropout rates, and fine arts course taking. Additional reports, including reports based on assessment data, will be added in the future. We encourage you to explore this portal and to share this link with your district staff for their use.

NOTE: EDStats cannot be bookmarked after entry into the portal. You must access it directly from the hyperlink (https://edstats.fldoe.org/SASPortal/public), or you can create a shortcut on your desktop by 1) Clicking on the above link to the Portal, 2) from the Browser window that opens, right-click on the center of the page, and click "Create shortcut" and "Yes" button to place on desktop, 3) navigate to the shortcut on your desktop and right-click on the shortcut icon and click "Properties", 4) from the Web Document tab, delete the URL in the URL box and then copy and paste https://edstats.fldoe.org/SASPortal/public into the box, click "Apply" and "OK.

Reporting Title I, Part D Neglected or Delinquent Students in Survey 9

The data element, *Institution Number, Neglected/Delinquent*, applies to institutions for neglected or delinquent (N/D) children as defined in Title I, Parts A and D of the Elementary and Secondary Education Act, as amended by Public Law 107-110. The data reported are required for funding of districts' Title I N/D programs and are submitted to the US Department of Education.

Report the Institution Number, Neglected/Delinquent (N/D) in Survey 9 for students who are ages 5-17, inclusive, who resided or were served in an institution for neglected or delinquent children for at least one day during the designated 30-day count period in the reporting year.

School Environmental Safety Incident Report (SESIR)

As a reminder, a SESIR record should be submitted during reporting periods 2, 3, and 5 for each SESIR incident and for each incident of Unsubstantiated Bullying (UBL) and Unsubstantiated Harassment (UHR) occurring on school campus, at school-sponsored events occurring off campus, on school-sponsored transportation or at bus stops at any time of the year and twenty-four hours a day. The SESIR records submitted for reporting periods 2 and 3 should be from the first day of the school year to the last day of the survey period. The SESIR records submitted for reporting period 5 should be from the first day of the school year to the start of the next school year.

Public Schools Administrative and Instructional Staff Terminations Database

In accordance with section 1012.21(2) Florida Statutes...concerning (a) "a computer database containing the names of persons whose employment was terminated," (b) each district school superintendent shall report to the Department of Education the name of any person terminated under s. 1012.33(1)(a) or (4)(c) within 10 working days after the date of final action by the district school board on the termination. Submit this record for any school administrator or instructional staff member employed (or previously employed) by the school district who was dismissed due to findings by the Board related to charges.

This is a reminder to all public school districts that the Staff Terminations database is active and should be current at all times. If the database is not current, records should be added for school administrators and instructional staff members who were terminated but are not currently listed in the database. The database should be used to continue to adhere to the requirements of the statute to assist in employment verifications to foster a successful and safe learning environment for students in Florida's public schools.

Staff Email Address Data Collection

According to section 1012.05(3)(b), Florida Statutes, "By September 15 and February 15 of each year, each school district shall electronically submit accurate public school e-mail addresses for all instructional and administrative personnel, as identified in s.1012.01(2) and (3), to the Department of Education." The submission period for the February 15th data collection is from January 18, 2016 to February 12, 2016. Files will begin processing on January 18, 2015 on a daily basis during the data collection processing period at 4:00 p.m. up to the final processing date on Friday, February 12th. Florida Education Identifier (FLEID) Update

During the 2014 session, the Florida Legislature mandated that the Florida Department of Education (FDOE) establish a process for assigning a Florida student identification number. During the summer of 2015, the FDOE began processing district submissions of current student records for FLEID assignment. In November, processing began for college student records. As of mid-November, over three million student records from districts and colleges were processed in the FLEID system.

As a reminder, districts are to submit student FLEIDs along with existing identifiers for the 2016-17 student survey submissions. Beginning in 2017-18, the FLEID will become the primary student identifier.

Federally Connected Student Indicator—Survey 3

The new data element, *Federally Connected Student Indicator*, will be collected in Survey 3 on the *Federal/State Indicator Status* format. This indicator identifies students in their district of enrollment who are connected with federally-owned military installations, National Aeronautics and Space Administration (NASA) owned property and federally-owned Indian Lands. Reporting for this data element requires compliance with the Survey Due Date and the State Processing Period.

Only districts that are eligible for Federal Impact Aid funding under Section 8003, Title VIII of the Elementary and Secondary Education Act of 1965 will report these data. To determine if the district is eligible for the federal aid, visit the US Department of Education's web site and click on "Basic Support Payments (8003)." Link to the web site is: http://www2.ed.gov/about/offices/list/oese/impactaid/whatisia.html.

This new state data element does not take the place of existing federal reporting requirements. For eligible districts to continue to earn Federal Impact Aid funding under Section 8003, Title VIII of the Elementary and Secondary Education Act of 1965, the district must continue to report data and submit applications to the Federal Impact Aid Program as appropriate.
