# **SUBJECT: Upcoming Spring 2015 CELLA Reports**

Once approved by the Florida Department of Education, the Spring 2015 CELLA Reports will arrive via Questar Assessment, Inc. (Questar). As a result, the following scheduled delivery dates are tentative:

## 2015 CELLA Electronic Files are scheduled to arrive on May 15, 2015.

The following files will be accessible ONLY via ServicePoint (<u>http://fl-servicepoint.questarai.com/</u>):

- District Results File a file listing specific student information for students in the district who participated in the CELLA. The file will be available in both pipe-delimited and fixed width formats, with file layouts included to enable interpretation of each format.
- Master List of School-Level Login File a file listing login information for each participating school to access ServicePoint. **Note:** Schools can access ServicePoint on or after May 22, 2015.

# 2015 CELLA Electronic Score Reports are scheduled to arrive on May 22, 2015.

The following reports will be accessible ONLY via ServicePoint:

- Spring 2015 CELLA District Report a report listing all of the schools in a district who participated in the testing program, organized by grade, with summaries for that district.
- Spring 2015 CELLA School Report a report listing all students tested at the school, organized by grade, including summaries for that school.

## 2015 CELLA Individual Student Report (ISR) is scheduled to arrive on May 22, 2015.

The following will be packaged by school and shipped to the district office:

- Spring 2015 CELLA ISR a printed report for each student. Two (2) copies of the ISR are provided: one copy for the student/parent and a second copy to be retained in the student cumulative folder.
- A hardcopy of the school's login information to access ServicePoint.

## 2015 Secure Materials Missing Reports are scheduled to arrive on June 12, 2015.

The following reports will be accessible ONLY via ServicePoint:

- District Secure Materials Missing Report a report listing all secure materials, organized by school, with summaries for the district that were not returned to Questar after test administration.
- School Secure Materials Missing Report a report listing all secure materials that were not returned to Questar after test administration.
