Colleagues,

The Division of Career and Adult Education is gathering information on district policies regarding classroom instructional hours necessary to earn industry certifications on the Comprehensive Industry Certification List. The survey requests information on the number of classroom instructional hours necessary to earn certifications offered in your district during the 2010-11 school year.

Your estimate of instructional hours should be based only on instructional time required to earn the specific certification. For example, if the student would typically earn the certification after completing the third course in a sequence of CTE courses, the instructional time should be based on the percentage of hours in those classes that relate specifically to the competencies for earning that certification. If those courses include competencies that are not required to earn the certification, that instructional time should not be included.

The survey has been created in Microsoft Excel and must be saved to your own computer. To assist you in identifying certifications the list is sorted first into all certifications on the CAPE Funding List, followed by new certifications added to

the Comprehensive List, and followed by all remaining certifications sorted alphabetically by title. Responses should be typed directly into the survey and returned in the Excel format with your response. Please provide contact information in case additional follow-up is needed. Once complete, please save the survey to your computer and send as an attachment to [tara.mclarnon@fldoe.org](mailto:tara.mclarnon@fldoe.org).
