PLACEMENT DETAILS FOR CERTIFICATE PROGRAMS – LEVEL 1, LEVEL II AND LEVEL III

LEVEL III

Completed OCP in a TOL program and Hourly Wage of \$9 or more

1. Student was NOT enrolled in the same CTE program in the next year, AND
2. Student's OCP was in a program linked to an occupation on the Targeted Occupations Regional or Statewide list, AND
3. Student was found employed in Florida with an estimated hourly wage of \$9.00 or more (4th Qtr 09 or 1st Qtr 10)

OR

Military Placement

1. Student was NOT enrolled in the same CTE program in the next year, AND
2. Student was found in the military

LEVEL II

Employment at \$7.50/hour or more

1. Student was not a Level III (see above), AND
2. Student was NOT enrolled in the same CTE program in the next year, AND
3. Student was found employed in Florida with an estimated hourly wage of \$7.50/hour or more (4th Qtr 09 or 1st Qtr 10)

OR

Continuing Education

1. Student was NOT enrolled in the same CTE program in the next year
2. Student was enrolled in college credit program at a community college or university

LEVEL I

Any Employment

1. Student was not a Level III or II (see above), AND
2. Student was NOT enrolled in the same CTE program in the next year, AND
3. Student was found employed in Florida in the 4th quarter of 2009 (Oct-Dec) OR the 1st quarter of 2010
