Certification Funding List

On August 23, 2023, the State Board of Education (SBOE) approved an amendment to Rule 6A-6.0576, Florida Administrative Code (F.A.C.), CAPE Industry Certification Funding List. The approval is in accordance with section (s.) 1008.44, Florida Statutes (F.S.), which requires the Department of Education to adopt a CAPE Industry Certification Funding List.

The rule includes the following changes:

- 1. Adoption of the 2023-2024 CAPE Industry Certification Funding List;
- 2. Adoption of the 2023-2024 Master Credentials List (MCL) and updates to references to the 2023-24 MCL;
- 3. Updates to statutory references;
- 4. Removal of references to CAPE Innovation Courses;
- 5. Creation of a new subparagraph to address the Department's role in reviewing and approving CAPE Digital Tool Certificates and adoption of the new FCAPE-05 form submissions;
- 6. Removal of language limiting the registration of career-themed courses to an approved list of industry certification offerings for each eligible course;
- 7. Addition of language clarifying lagged reporting of CAPE Industry Certifications;
- 8. Modification to the FCAPE-04 form to clarify what information should be reported for a testing violation; and
- 9. Creation of a new section to address student conduct during test administration.

Action Required

School Districts and Florida College System (FCS) institutions may update their local management information systems to report the new industry certifications for the current reporting year (2023-2024). For school districts, performance funding is lagged one year; therefore, funds may be generated in the 2024-2025 fiscal year based upon reporting of earned certifications in the 2023-2024 reporting year. For FCS institutions, postsecondary performance funding is not lagged; therefore, certifications reported by the funding cut-off in May would be able to generate performance funding for the 2023-2024 disbursement, anticipated for June 2024.

A copy of the rule and associated lists are attached for your reference. An additional 33 new industry certifications and five new digital tools certificates are included on the 2023-2024 CAPE Industry Certification Funding List. See the column titled "New Certifications" on the attached list to identify these credentials. For funding eligibility see columns titled "2022-2023 K-12 FEFP Funding Eligible" and "2022 - 2023 Postsecondary Funding Eligible."
