Colleagues:

Through a partnership with the Florida Association for Career and Technical Education (FACTE) and CareerSource Florida, the Florida Department of Education (FDOE) is pleased to continue to support registered apprenticeship program growth and expansion with the announcement of the federally funded **Apprenticeship State Expansion (ASE) Grant**. We are pleased to inform you that grant information is now posted on the [Apprentice Florida](#) website.

These federal ASE Grant funds, in conjunction with the recently awarded state appropriated Pathways to Career Opportunities Grant Program, aim to expand existing registered apprenticeship programs. The grant funds support Florida's goal to become number one in workforce education by 2030.

To these ends, the ASE Grant will support two mini-grant initiatives, the first of which is the ASE "Program Grant", which consists of \$320,000 in funding, available in awards of up to \$20,000 each, for eligible registered apprenticeship programs.

- Programs must have a registration date on or after July 1, 2019 or have expanded into a new occupation during this timeframe and at the time of application be actively training apprentices in programs fully registered with the Florida Department of Education.
