District Contacts Meeting for Deaf/Hard of Hearing (DHH), Visually Impaired (VI) and/or Dual-Sensory Impaired (DSI)

District contacts will meet to discuss strategies for maximizing the instructional time of itinerant teachers, the proper procedures for determining eligibility for services, and methods for filling staff vacancies. This joint meeting will be on April 7, 2022, from 1 to 3:30 p.m. EDT, and April 8, 2022, from 9 a.m. to noon EDT. Best Practices for Inclusive Education (BPIE) Assessment

The BPIE assessment is an internal process designed to facilitate the analysis, implementation and improvement of inclusive educational practices. Section 1003.57, Florida Statutes (F.S.), requires that once every three years, each school district and school must complete a BPIE assessment. Florida Inclusion Network (FIN) facilitators are required to assist school districts in this process. The results of this process, including all planned short- and long-term improvement efforts, must be included in each school district's ESE policies and procedures.
