#### Position Available in the Bureau of Exceptional Education and Student Services (BEESS)

The Student Support Services Project in BEESS is also seeking a school psychology consultant. The school psychology consultant will collaborate with consultants from other student services professions as part of the Student Support Services Project. The school psychology consultant is responsible for collaborating, communicating, disseminating information and providing leadership to school districts, other discretionary projects and the Florida Department of Education (FDOE) regarding effective school psychology practices and programs. The consultant will provide strong leadership in promoting the implementation and best professional practices in the delivery of school psychological services, and utilizing an integrated student support services model within an MTSS including team-based problem-solving and response-to-intervention practices. # New Executive Director for the Multiagency Network for Students with Emotional/Behavioral Disabilities (SEDNET) Administration Project and Youth Mental Health and Awareness Training Grant

We are very pleased to inform everyone that Dr. Charlene Grecsek has accepted the position of executive director for the SEDNET Administration Project and Youth Mental Health and Awareness Training grant at the University of South Florida St. Petersburg (USFSP). Charlene obtained her doctoral degree in counseling psychology in 2001, completing her dissertation on the "Overrepresentation of Minorities in the Juvenile Justice System." Charlene has been a licensed mental health counselor since 1996 and a state-approved clinical supervisor since 1999. She serves as the South Region director for suicide prevention for the state of Florida. Charlene has most recently served as the SEDNET coordinator for Broward County for the past 11½ years, collaborating with the area managing entity, local funders, community leaders and discretionary projects to improve the lives of youth and families. She has presented at over 75 conferences on mental health, mindfulness, trauma, and childhood mental health and development. Charlene is a specialized trainer in the area of brain and development and received specific instruction in the Neurosequential Models in Education, under the guidance of Dr. Bruce Perry and Trauma Academy. Before her work with SEDNET, Charlene served as director of a community mental health agency. She has also instructed as an adjunct in the following courses: Community Counseling, Developmental Psychology, Culture and Counseling, and Group Counseling. #### 2020 Census

Once a decade, America comes together to participate in the decennial census. There are critical programs that the census supports through capturing a count of citizens, which include local health care, housing, education, transportation, employment and public policy. In mid-March 2020, the Census Bureau will mail letters to inform people that they have been selected to participate in the American Community Survey and will include instructions for participants to respond in one of three ways: online, by phone or by mail. In Florida, we have many hard-to-reach areas and in order to reach these families, a paper questionnaire may be requested. Schools play an important role in supporting all students and families (including homeless students) in completing this task. It is important to educate families on the importance of the census.
