Florida Positive Behavioral Interventions and Supports (FLPBIS) Project Resources

The FLPBIS Project recently developed several resources for district and school leaders. The <u>Classroom Workbook: How to Use Classroom PBIS Materials</u> is a tool for new teachers and classroom coaches to utilize in establishing best practices for positive behavior within the learning environment. The <u>Multi-Tiered Systems to Build Resiliency Infographic</u> is a resource for district and school leaders working to align behavioral instruction initiatives within a multi-tiered system of supports (MTSS) in the promotion of resiliency. Additionally, two infographics are now available that define the role and function of <u>Tier 3 District-Level Systems</u> and <u>Tier 3 School-Level Systems</u> within a behavioral MTSS. These resources can assist leaders in reviewing current structures and identifying key features of an effective Tier 3 system for behavior.

Para to Teacher Support Program Will Soon Provide Financial Assistance for Degrees in Early Childhood/PreK Disabilities

The Para to Teacher Support Program is pleased to announce funding for Florida's first online degree program in Early Childhood Education with a PreK disabilities endorsement. The new online bachelor's degree program at the University of Florida (UF) is set to commence in the fall. Paraprofessionals who do not yet hold a bachelor's degree and want to become teachers in early childhood/PreK disabilities can apply for the UF program and financial assistance through the state-funded Para to Teacher Support Program. 2024-25 No-Cost Application for Federal Student Aid (FAFSA®) Form

Now is the time for high school seniors and returning college students to submit their 2024-25 no-cost application for Federal Student Aid (FAFSA®) form, an application that students and families need to complete to apply for federal student aid, such as federal grants, work-study funds, and loans. The revamped FAFSA form—also known as "Better FAFSA"—takes many students less than 20 minutes to complete and can unlock up to \$7,395 in federal aid that does not need to be repaid to help cover the cost of college.
