The BPIE assessment is an internal process designed to facilitate the analysis, implementation and improvement of inclusive educational practices. Section 1003.57, Florida Statutes, requires that once every three years, each school district and school must complete a BPIE assessment. The school BPIE assessment online system will be updated **between September 1 and 30, 2022**.
