## Additional Extension for Fall 2022 English Language Arts (ELA) Retakes and End-of-Course (EOC) Assessments

Due to school closures, a statewide extension has been granted for all schools and districts through **October 14, 2022**, for the following assessments:

- Fall 2022 ELA Retake (Reading and Writing)
- Fall 2022 EOCs (Algebra 1, Biology 1, Civics, Geometry and U.S. History)

If your district is in need of additional flexibilities, the Bureau of K–12 Student Assessment will work with you individually as your schools are back in session. The Florida Assessment of Student Thinking (FAST) PM1 K–2 and 3–10 window will conclude **October 7, 2022**. Please note any deactivations or nonparticipation statuses for K–2 in Renaissance, and mark invalidations for 3–10 in TIDE by 5 p.m. EDT. There will be no additional extensions for FAST PM1. Additional information on FSAA test windows is forthcoming from the Service Center.

The U.S. Department of Education's Office of Special Education Programs, and the U.S. Department of Health and Human Services' Office of Head Start are releasing new documents to encourage collaboration between state educational agencies (SEAs), local educational agencies (LEAs), and Head Start programs to effectively meet the Individual with Disabilities Education Act (IDEA) requirements. These documents make clear that SEAs, LEAs, and Head Start programs all have responsibilities for implementing IDEA to ensure that children with disabilities enrolled in Head Start programs receive a free appropriate public education in the least restrictive environment.

In order to motivate students and support them in setting reading goals in Florida, Learning Ally, a discretionary project funded through BEESS, has created a program called 33 and Me! This program builds strong reading habits by supporting students in setting reading goals to move them toward 33 days of reading for 20 minutes per day. Based on an extensive review of Learning Ally reading data, 33 days of reading for 20 minutes per day is a reliable indicator that students are developing the habit of reading and are ready to skyrocket into even higher levels of reading achievement.
