Individuals with Disabilities Education Act (IDEA) Part B, American Rescue Plan (ARP) Act Technical Assistance Training

The Bureau of Exceptional Student Education (bureau) is pleased to announce a technical assistance training regarding the Individuals with Disabilities Education Act (IDEA) Part B, ARP Act grant application submission. The technical assistance workshop will be on **January 18, 2022**, prior to the application submission deadline of **January 31, 2022**. The purpose of this training is to provide additional technical assistance on the following topics of interest:

- Completing and submitting an IDEA ARP budget in the Online Grants System;
- Location for submission of the IDEA ARP DOE-100A and Excel Application (where to submit the documents);
- Retrieving and transferring existing application data regarding CEIS/CCEIS, MOE and Proportionate Share needed for completing the IDEA ARP Excel Application; and
- Overview of allowable expenditures for IDEA ARP funds.

Statewide Strategic Instruction Model (SIM) Virtual Professional Learning Opportunity

The Florida Diagnostic and Learning Resources System (FDLRS) Administration is excited to offer a statewide SIM virtual professional learning opportunity on March 2-3, 2022. Certified SIM "PDers" will be conducting virtual afterschool sessions on the Concept Comparison Routine. Teachers and students use this routine to explore the characteristics of two or more concepts, identify the characteristics that are shared or not shared by the concepts, name overarching categories for sets of characteristics they have identified, and summarize the similarities and differences. Research with students enrolled in general education secondary science and social studies classes showed that students correctly answered substantially more test questions related to information that had been presented through the Concept Comparison Routine than through test questions related to information presented using traditional teaching methods. Students with learning disabilities and other low-achieving students correctly answered an average of 71.2 and 86.4 percent, respectively, of the test questions associated with information presented through the use of the routine, compared to 56.7 and 62.6 percent of the questions associated with information presented through traditional means. The experimental study involved 107 students. To view the study results and additional information, go to https://sim.ku.edu/. Seats are limited so be sure to have those interested register early and prior to February 11, 2022. SIM has been showcased in the What Works Clearinghouse and is internationally known to provide effective teaching strategies for students in grades 4 through 12 and beyond. This would be a great

professional learning activity for those new to SIM or those already implementing them but wanting to expand their repertoire.
