### **Restraint Incident Data**

Section 1003.573(8)(c), Florida Statutes, states: "The department shall maintain aggregate data of incidents of restraint and disaggregate the data for analysis by county, school, student exceptionality, and other variables, including the type and method of restraint used. This information shall be updated monthly, deidentified, and made available to the public through the department's website ..." Therefore, monthly restraint reports will be posted on the BESE website at <a href="https://www.fldoe.org/academics/exceptional-student-edu/data/">https://www.fldoe.org/academics/exceptional-student-edu/data/</a> on the first of every month. As a reminder, the data posted are lag data, e.g., August data were posted on October 1, 2021, and September data were posted on November 1, 2021. ### Survey on Braille Versions of Florida Statewide Assessments

Teachers of students with visual impairments and other district staff administering braille versions of the Florida Standards Assessment or the Next Generation Sunshine State Standards Florida Statewide Assessments are asked to provide feedback to the Florida Department of Education Bureau of K-12 Student Assessment and the Florida Instructional Materials Center for the Visually Impaired (FIMC-VI) using the provided feedback form. Survey respondents will have the opportunity to indicate quality issues related to the braille paper, braille dots, braille notes and scripts, tactile graphics, thermoformed pages, page numbering, binding, page order, and more. Nominations due **Monday**, **November 15**, **2021** at 6:00 PM EST (*Nomination packages received after this deadline will not be accepted*)

### **Award Description:**

The **Children's Week Florida**<sup>TM</sup> **Youth Advocate Award** is presented to a young person who has initiated or diligently worked on behalf of positive change in support of programs or policies that benefit children, youth, and families in their school, community, or statewide.

This year's youth recipient will be honored on Monday, January 31, 2022 during the Children's Week Florida<sup>™</sup> Advocacy Reception and Awards Ceremony. They will also be invited to participate in the Children's Week Florida<sup>™</sup> Teen Town Hall on Tuesday, February 1, 2022 helping inspire other young minds.

### **Eligibility Criteria:**

- Anyone can submit a nomination (e.g. teachers, parents, mentors, students) or a youth may nominate themselves.
- Youth nominees must be under 18 or still in school (K -12) at the time of nomination.
- Youth nominees should be currently involved in advocacy efforts or actively encouraging ongoing advocacy efforts to improve the lives of children, youth and their families at the local or state level.

### **Required Nomination Package Components:**

- 1. Nomination Form Must complete all fields of the form and sign.
- 2. Narrative Summary & Personal Statement Provide a narrative summary or personal statement that describes the youth nominee's contributions and/or commitment to serving children, youth, and families (total 750-word maximum).
- 3. **Photo** Include a photo of nominee in jpeg or png format.

### **Additional Information:**

- All nominations will be reviewed by the Children's Week Florida<sup>™</sup> Advocacy Awards Committee, a volunteer peer review group consisting of previous Chiles Advocacy Award winners and other advocates.
