<b>Definition/Domain</b>	
THESE CODES ARE USED ONLY FOR VOCATIONAL STUDENTS. Indicate whether or not the student was academically disadvantaged during the reporting year (secondary) or term (postsecondary).	
<u>CODE</u>	<u>DEFINITION</u>
A	"Academic disadvantaged" means individuals (other than individuals with handicaps) who have academic disadvantages AND <u>WHO REQUIRE SPECIAL SERVICES AND ASSISTANCE IN ORDER TO SUCCEED IN VOCATIONAL EDUCATION PROGRAMS</u> . This includes individuals who are:  migrants;  Limited English proficient; or  dropouts, or who are identified as potential dropouts, from secondary school. (PL 101-392, the Carl D. Perkins Vocational and Applied Technology Education Act Amendments of 1990)  The following indicators may be used with the above definition to determine vocational academic disadvantage: <ul style="list-style-type: none"> <li>● The student is enrolled in remedial instruction in reading, writing or mathematics.</li> <li>● The student has secondary school grades below 2.0 on a 4.0 scale (Grade "A" equals 4.0).</li> <li>● The student has scored at or below the 25th percentile for the student's grade level on a standardized achievement or aptitude test.</li> <li>● The student is failing a grade.</li> <li>● The student is on academic probation (for adults).</li> </ul>
