

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

1. District Number, Current Enrollment must be numeric and in the range 01-70 or 72-76. -record rejected-

EXAMPLE

The first two records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected since the District Number, Current Enrollment is not within the appropriate range.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the District Number, Current Enrollment and resubmit the record.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

2. **School Number, Current Enrollment must be numeric in the range 0001 to 9899 or it must be N998 or N999. -record rejected-**

EXAMPLE

The first two records listed below would be loaded to the data base assuming no other reject rule would cause the records to be rejected. The last two records would be rejected. The first of these would be rejected because the School Number, Current Enrollment is not in the appropriate numerical range. The second of these two records would be rejected because the School Number, Current Enrollment is not numeric, N998 or N999.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the School Number, Current Enrollment and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

3. The first nine positions of Student Number Identifier, Florida must be numeric. The tenth position of Student Number Identifier, Florida must either be an "X" or numeric. If the tenth position of Student Number Identifier, Florida is numeric, the first two digits must be a valid district number in the range 01-70 or 72-76. -record rejected-

Note: For more information on Student Number Identifier, Florida refer to DOE Information Data Base Requirements: Volume I -- Automated Student Information System Manual.

EXAMPLE

The first two records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because when the social security number is used as the Student Number Identifier, Florida, the tenth position must be an "X". The fourth and sixth records would be rejected because the Student Number Identifier, Florida contains blanks. The fifth record would be rejected because the first two digits are not a valid district number.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Student Number Identifier, Florida and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

- 4. Survey Period Code must be F, W, or S and must be correct for the submission specified by the district. -record rejected-**

EXAMPLE

If the Survey Period Code as specified in the transmission JCL or in the statements for tape transmission was identified as Survey Period Code "W" and records were coded with Survey Period Code "F", all updates, adds, or deletes with this inconsistency would be rejected.

DISTRICT RESPONSIBILITY

The District must correct the Survey Period Code either on the transmission JCL or on the records and resubmit the records.

- 5. Fiscal Year must be correct for the submission specified by the district. -record rejected-**

EXAMPLE

The Fiscal Year as specified in the transmission JCL or in statements for tape transmission is identified as "9900". However, records on the transmission have Fiscal Year coded as "9899". All updates, adds or deletes with this inconsistency would be rejected.

DISTRICT RESPONSIBILITY

Correct the Fiscal Year either on the records coming in or the transmission JCL and resubmit all records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

6. District Number, Current Instruction/Services must be numeric in the range 01-70 or 72-76 and must be correct for the district submitting the data. -record rejected-

EXAMPLE

If district 01 is submitting records, District Number, Current Instruction/Services must be 01 for all records. In the records listed below, the first two records would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected since the District Number, Current Instruction/Services is 02 rather than 01 (the number of the district submitting the record).

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the District Number, Current Instruction/Services and resubmit the record.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

7. The School Number, Current Instruction/Services must be numeric in the range 0001-9899. -record rejected-

EXAMPLE

The records listed below would be rejected. The first record would be rejected because the School Number, Current Instruction/Services is not within the valid range of numbers. The second record would be rejected because the School Number, Current Instruction/Services is not numeric.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the School Number, Current Instruction/Services and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

8. The Vocational/Adult General Education Program Code must be a postsecondary vocational education program number on the Vocational/Adult General Education Program Edit file (F61730). -record rejected-

Note: For more information on Vocational/Adult General Education Program Codes refer to the Workforce Development Data Base Handbook appendices.

EXAMPLE

The first and second records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because the Vocational/Adult General Education (AGE) Program Code is not a valid postsecondary vocational program number.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the Vocational/Adult General Education Program Code and resubmit the record.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

9. Course Number must not contain blanks and must be a valid postsecondary vocational Course Number (other than "local use only transfer" courses) on the Vocational/Adult General Education Program Edit file (F61730). (See Workforce Development Data Base Handbook appendices for a list of valid Course Code Directory courses.) -record rejected-

EXAMPLE

The third record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The first and second records would be rejected because the Course Number contains blanks or is not a valid Course Number.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Course Number and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

10. **Section Number must not be all blanks. -record rejected-**

EXAMPLE

The first, second and third records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The fourth record would be rejected because the Section Number contains all blanks.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the Section Number and resubmit the record.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

11. Period Number must be 9999. -record rejected-

EXAMPLE

The first record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The second and third records listed below would be rejected because Period Number is not 9999.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Period Number and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

12. Vocational Special Initiatives must be coded as follows:

Position	Valid Codes
1	C or Z
2	Y or Z

-record rejected-

EXAMPLE

The first and second records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because the Vocational Special Initiatives code in the second position is blank. The fourth record would be rejected because the Vocational Special Initiatives codes are invalid.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Vocational Special Initiatives code and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

13. Term must be either 1-9, B-O or R-X. -record rejected-

EXAMPLE

The record in the first example listed below would be rejected because the Term code is invalid. The second record would be rejected because the Term code was left blank.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Term and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

14. Vocational/Adult General Education Student Membership Hours must be numeric and greater than zero. -record rejected-

EXAMPLE

The fourth record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The first, second and third records would be rejected because the Vocational/Adult General Education Student Membership Hours is not greater than zero, contain blanks, or is not numeric.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Vocational/Adult General Education Student Membership Hours and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

15. **Date of Entry must be a valid date in the format of MMDDYYYY, where MM is a valid month (01-12), DD is a valid day (01-31) and YYYY is a valid year (1981-2000). -record rejected-**

EXAMPLE

The first and second records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third and fourth records would be rejected because the Date of Entry is in the wrong format.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Date of Entry and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

16. **Date of Entry must be a date less than the current date. -record rejected-**

EXAMPLE

Assuming that the records below were submitted for the Fall reporting period in 1999, the first and second records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because the Date of Entry is not less than the current date.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Date of Entry and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

17. Vocational/Adult General Education Termination Code must be C, R, S, or Z. -record rejected-

EXAMPLE

The sample records listed below would be rejected. The first record would be rejected because the Vocational/Adult General Education Termination Code is invalid. The second record would be rejected because the Vocational/Adult General Education Termination Code is left blank.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Vocational/Adult General Education Termination Code and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

18. Vocational/Adult General Education, Disability Student code must be I, N or Z. -record rejected-

EXAMPLE

The first record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The second record would be rejected because the Vocational/Adult General Education, Disability Student code is invalid. The third record would be rejected because the Vocational/Adult General Education, Disability Student code is blank.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

19. **Grade Level must be 09-12, 30 or 31. -record rejected-**

EXAMPLE

The first, fifth and sixth records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The second, third and fourth records would be rejected because Grade Level is invalid.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Grade Level and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

20. The Transaction Code must be A, C or D. For the original transmission, only A is valid. For subsequent batch/update submissions, if A is specified then the record must not already exist on the data base; if C or D is specified then the record must exist on the data base. -record rejected-

EXAMPLE

For all original transmissions, the Transaction Code must be "A". An original transaction is the first submission of a record during a survey period. After original transmission of records, changes to the record for elements other than the key elements must be done with a "C" as the Transaction Code. To delete a record, the Transaction Code must be a "D". To change key elements in a batch transaction, the record must FIRST be deleted with a "D" and then added with an "A". Records with an incorrect Transaction Code would be rejected.

DISTRICT RESPONSIBILITY

If the rejected records should not have been submitted, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must correct the Transaction Code and resubmit the records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

21. Each record must be unique based on Student Number Identifier, Florida; Survey Period Code; Fiscal Year; District Number, Current Instruction/Service; School Number, Current Instruction/Service; Course Number; Section Number; Period Number and Term. -First record accepted, all other duplicate records rejected-

EXAMPLE

The fifth and eighth records listed below would be rejected because the key items (Student Number Identifier, Florida; Survey Period Code; Fiscal Year; District Number, Current Instruction/Service; School Number, Current Instruction/Service; Course Number; Section Number; Period Number and Term) duplicate the key items in a previous record. The first of two records with the same key information will be loaded to the data base file, assuming it meets all other applicable criteria. Any subsequent records submitted with duplicate data in all the key items would be rejected.

DISTRICT RESPONSIBILITY

If the records that were accepted and loaded to the data base are the correct ones, no action is required. However, if the district wishes the data in the rejected records to be loaded to the data base, the district must delete any invalid records, correct any rejected records if necessary, and resubmit the corrected records.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

22. Special Appropriation code must be A, B, or C. -record rejected-

EXAMPLE

The first two records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because the Special Appropriation code is not valid.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

23. If Special Appropriation code equals A or B, then the Cost Reporting Code must equal 450. -record rejected-

EXAMPLE

The first two records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because the Cost Reporting Code is not valid for the Special Appropriation code.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the Special Appropriation code or the Cost Reporting Code and resubmit the record.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

24. Vocational Instructional Setting/Method code must be B, D, E, F, L, M, P, R, S, or Z. No code should be reported more than once. -record rejected-

EXAMPLE

The first and third records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The second record would be rejected because the Vocational Instructional Setting/Method field contains an invalid code.

DISTRICT RESPONSIBILITY

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

**25. On the Same WDIS Vocational Student Course Schedule record, only one of the Vocational Instructional Setting/Method codes E, S or M may be reported.
-record rejected-**

EXAMPLE

The first and third records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The second record would be rejected because the Vocational Instructional Setting/Method contains an invalid combination of codes.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

26. Vocational Instructional Setting/Method code Z may not be used in combination with Vocational Instructional Setting/Method codes B, D, E, F, L, M, P, R or S. -record rejected-

EXAMPLE

The first and third records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The second record would be rejected because the Vocational Instructional Setting/Method contains an invalid combination of codes.

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the Vocational Instructional Setting/Method and resubmit the record.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

27. **Cost Reporting Code must equal 340, 350, 360, 370 or 450. -record rejected-**

EXAMPLE

The first record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The second record would be rejected because the student has a Cost Reporting Code of 400, which is invalid for this format.

**28. If Vocational/Adult General Education Termination Code equals Z, the Vocational/Adult General Education Completion Point Code must equal Z.
-record rejected-**

EXAMPLE

The first record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The second record would be rejected because the Vocational/Adult General Education Termination Code is incompatible with the Vocational/Adult General Education Completion Point Code.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the Vocational/Adult General Education Completion Point Code and resubmit the record.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

29. If Vocational/Adult General Education Termination Code equals C, S, or R, the Vocational/Adult General Education Completion Point Code must not equal Z.
-record rejected-

EXAMPLE

The first record listed below would be loaded to the data base assuming no other reject rule would cause its rejection. The second record would be rejected because the Vocational/Adult General Education Completion Point Code is Z.

DISTRICT RESPONSIBILITY

If the rejected record should not have been submitted, no action is required. However, if the district wishes the data in the rejected record to be loaded to the data base, the district must correct the Vocational/Adult General Education Completion Point Code and resubmit the record.

WDIS VOCATIONAL STUDENT COURSE SCHEDULE - REJECT RULES

30. Vocational/Adult General Education Student Membership Hours must not exceed 2000 hours. -record rejected-

EXAMPLE

The first two records listed below would be loaded to the data base assuming no other reject rule would cause their rejection. The third record would be rejected because Vocational/Adult General Education Student Membership Hours exceeds 2000 hours.
