**Definition/Domain**

<u>CODE</u>	<u>DEFINITION</u>
<b>C</b>	A student who has completed a planned sequence of competencies or courses and met all of the requirements of the institution for <u>occupational or literacy completion</u> . This student has achieved one or more literacy completion points or occupational completion points and <b>exited the program</b> .
<b>S</b>	A secondary student who has achieved an occupational or literacy completion and exited the program, <u>but is still in secondary school</u> .
<b>R</b>	A student who is <b>remaining in the occupational or literacy instruction</b> .
<b>Z</b>	None of the above. See the secondary vocational data base handbook and the district workforce development education data base handbook for lists of codes and titles for which the termination code will always be "Z".
