<b>Definition/Domain</b>	
<p>For <u>secondary students</u>:</p> <p>Record the seven-digit numeric program code listed in the <u>Course Code Directory</u>, which is associated with the vocational course in which the student is enrolled.</p> <p>For all <u>postsecondary adult vocational students</u>:</p> <p>Record the seven-digit alphanumeric program code listed in the <u>Course Code Directory</u>.</p> <p>For the <u>adult general education students</u>:</p> <p>Record the appropriate valid code from the <u>Course Code Directory</u>.</p> <p><b>NOTE:</b> To report the appropriate code for dually enrolled students in FTE Surveys 1-4:</p> <ul style="list-style-type: none"> <li>◆ For regular secondary vocational students, enter the secondary program number. For a dually enrolled student taking a postsecondary adult vocational in a district setting, enter the postsecondary adult vocational program number. (See Appendix I in the WDIS Data Base Handbook for current program numbers.)</li> <li>◆ If reporting a dually enrolled student taking an academic or vocational class through a state university or community college, zero fill this field.</li> </ul> <p>In Survey 5, report only the instruction actually provided to the student by the school of instruction. Dual enrollment courses are reported in Survey 5 if the student took an industry certification or technical skill assessment listed in Appendix Z that is related to the dual enrollment course.</p>
