VPK Child Participation


Enrollment

The Early Learning Programs Estimating Conference meets regularly to revise its forecast for the VPK program, which is used to inform financial and operational planning for the VPK program. Participation rates have varied over the 20-year history of the program. Currently, two-thirds of Florida's four-year-olds participate in VPK.


Historical VPK Participation



Attendance

Attendance is critical to a child's success in any educational program. The charts below show VPK program attendance at certain attendance thresholds.

2024-2025 VPK Program Year Child Attendance




- 86% of children attended 70% or more of the VPK program (129,547 out of 150,615 children).
- 78% of children attended 80% or more of the VPK program (118,588 out of 150,615 children).
- 50% of children attended 90% or more of the VPK program (74,918 out of 150,615 children).

VPK Child Progress Monitoring

The Florida Department of Education adopted the Florida Assessment of Student Thinking (FAST) as its coordinated screening and progress monitoring system for students in grades VPK through 10. For the VPK program, FAST Star Early Literacy is used as the tool to monitor child progress. School year VPK programs must complete progress monitoring three times a year and summer VPK programs must complete progress monitoring two times a year.

FAST Star Early Literacy provides data to inform VPK educators and families on how to support a child's growth in emergent literacy and early math skills. The FAST Star Early Literacy Unified Scaled Scores (USS) are used to measure progress toward kindergarten readiness and range from 200 to 1100. In Florida, a child who earns a USS of 707 or higher at the end of the VPK program year has demonstrated "kindergarten readiness." The chart below reflects the percentage of VPK completers demonstrating kindergarten readiness from progress monitoring one (PM1) to progress monitoring three (PM3) for the past three VPK program years. VPK completers are children who completed 70% or more of the VPK instructional hours.

Percentage of Tested VPK Completers Scoring "Kindergarten Ready" and Above




The data show steady progression across each VPK program year and a three-percentage point increase in kindergarten readiness from 2023 to 2025. This represents approximately 4,500 more children exiting VPK kindergarten ready.

Child Participation and Progress Monitoring

The Division of Early Learning (DEL) analyzed the data further to determine whether other aspects of child participation have an impact on a child's kindergarten readiness. Children who participate more are more likely to demonstrate kindergarten readiness on the final administration of FAST Star Early Literacy.


This becomes evident when comparing VPK completers to VPK non-completers. The following chart shows that VPK completers are more likely to achieve kindergarten readiness on their final VPK progress monitoring assessment compared to their VPK non-completer peers.

The following chart indicates the percentage of children at different VPK attendance levels demonstrating kindergarten readiness on their final VPK progress monitoring assessment. The more VPK days that a child attends, the more likely the child will achieve kindergarten readiness on the final administration of FAST Star Early Literacy.

Percentage Achieving Kindergarten Readiness by Attendance Rates




VPK Program Assessment

VPK providers must annually take part in a program assessment of each VPK classroom. Program assessments measure the quality of teacher-child interactions within the classroom. Florida uses the Classroom Assessment Scoring System (CLASS), an evidence-based observational tool, to assess the quality of VPK programs.

CLASS evaluates providers on a 7-point scale; VPK providers must earn a composite score (an average score for all their VPK classrooms) of at least a 4.00 to be eligible to deliver VPK in the following program year. In 2024-2025, over 99% of VPK providers scored 4.00 or higher.

Data from previous and current VPK program years show that VPK providers are improving the quality of the teacher-child interactions occurring in the VPK classroom. From 2022-2025, the state average CLASS composite score increased from 5.08 to 5.31.

VPK CLASS composite scores reflect three domains of activities in a VPK classroom, which in turn are composed of nine dimensions.




In addition to providing insight into the overall quality of a VPK classroom, data at the domain and dimension level can identify strengths and opportunities for improvement that can be targeted with professional learning.

Nationally, early learning programs serving preschool children score higher in the emotional support and classroom organization domains than they score in the instructional support domain. Data show Florida's VPK providers are part of this nationwide trend.

VPK Provider Accountability

Historically, the VPK accountability system was based on kindergarten readiness assessment data collected for VPK completers at the beginning of their kindergarten year. There were several drawbacks to this approach.

- Not all VPK children attend public school kindergarten; therefore, VPK provider accountability was based only on a subset of VPK children.
- Data collected at the beginning of kindergarten, rather than at the end of the VPK program, was not the most reliable measure to use for measuring the effectiveness of VPK providers (e.g., summer slide impact, data only included VPK children attending public school).
- VPK providers received results about their program's effectiveness months into the next VPK program year delaying the provider's ability to make strategic improvements.

2024-2025 was the first year that VPK providers received performance metrics and designations under the new VPK accountability system.

- 6,240 providers delivered VPK services during the 2024-2025 program year.
- 95% of providers had sufficient data to receive a metric and designation.
- 5% of providers did not have sufficient data and are considered incomplete.

Statewide, 88% of VPK providers satisfactorily delivered VPK, earning a designation of Meets Expectations, Above Expectations or Excellent. The chart below displays the distribution of providers across all designations (and incomplete status) and the average CLASS scores, the average percentage of VPK children demonstrating achievement and the average percentage of VPK children demonstrating sufficient learning gains for each designation.

Providers on Probation

Providers that earn a designation of Below Expectations or Unsatisfactory are providers identified in need of improvement and placed on probation. A provider on probation (POP) is required to complete the following activities:


- Implement curriculum approved by the Department of Education.
- Ensure each VPK staff member completes 20 hours of staff development activities.
- Communicate the provider's probationary status to enrolled VPK families.

A provider on probation (POP) stays on probation until the provider:

- earns a designation of Meets Expectations, Above Expectations or Excellent;
- transfers ownership to an individual not associated with the provider; or
- completes a period of removal from VPK program eligibility.

A provider that earns a designation of Below Expectations or Unsatisfactory for three consecutive years must apply for a good cause exemption from DEL to deliver VPK instruction for the same program type (school year or summer). If the provider does not qualify for a good cause exemption, their eligibility to deliver VPK services is revoked for a period of time. The chart below reflects the distribution of providers in probationary or revoked status.

Probationary Status of VPK Providers




Providers that were on probation or operating under a good cause exemption based on the previous VPK accountability system of “readiness rates” were reset based on the results of the new VPK accountability system. Therefore, there are no providers currently in the second year of probation or requiring a good cause exemption.

A provider whose eligibility to offer VPK was revoked under the previous VPK accountability system continues to be ineligible to offer VPK until they have completed the period of removal.

VPK Provider Designations by Early Learning Coalitions

VPK providers that earn the designations of Meets Expectations, Above Expectations or Excellent are considered to have satisfactorily delivered the program. The map below displays the percentage of VPK providers in an Early Learning Coalition (ELC) service area that earned a designation indicating satisfactory VPK delivery.

VPK Participation and Later Success in School

Analyzing the progression of VPK children after VPK is critical to determine the long-term impact of Florida's VPK program. Measures of kindergarten readiness and grade level reading provide evidence of the VPK program's effectiveness at preparing students for later success in school.


Kindergarten Readiness

The Florida Department of Education requires public schools to assess children at the beginning of kindergarten to determine the readiness of all children entering the public school system.

The definition of kindergarten readiness at the beginning of kindergarten is aligned with the achievement expected of students at the end of the VPK program: a Unified Scaled Score (USS) of 707 or higher on FAST Star Early Literacy. A USS of 707 represents 70% mastery of the emergent literacy and early math skills needed for kindergarten readiness. The State Board of Education approved the new kindergarten readiness cut score in August 2024.

For years, VPK completers have outperformed their peers who did not participate in VPK, even as the definition of "kindergarten readiness" has evolved. For the 2022-2023 and 2023-2024 school years, kindergarten readiness was defined as achieving a USS of 690 or higher on FAST Star Early Literacy during the first progress monitoring window in kindergarten. The 2024-2025 school year was the first year that the higher USS of 707 was applied; therefore, 2024 Kindergarten Readiness results serve as a baseline year. Even though kindergarten readiness results for 2024-2025 cannot be compared to previous years due to the new higher standard, VPK children still outperform their peers who did not participate in VPK.

Kindergarten Readiness Results from 2022-2023 to 2025-2026 School Years



Florida’s families have many educational options to choose from when considering where to enroll their child in kindergarten. For the 2025-2026 school year, 70% of VPK children enrolled in kindergarten at a public school and 30% of children continue in other settings. Therefore, the kindergarten readiness data at the beginning of kindergarten represent a subset of VPK children.

Assessment results from public school kindergarten show that children who complete VPK are more likely to enter kindergarten ready for school, compared to their peers who did not participate in VPK. This holds true within several subgroups of kindergarten students in the 2025-2026 school year, as reflected in the chart below.



Grade Level Reading

Grade level reading by the end of third grade is a critical milestone for a child’s future education success, and a huge predictor of high school graduation. In fact, nearly 90 percent of students who did not graduate high school were struggling readers in third grade.

The chart below displays cohorts of VPK children’s performance on the FAST Grade 3 English Language Arts (ELA) assessment. The results demonstrate that the educational benefit of VPK participation lasts beyond kindergarten readiness. Children who participated in VPK were more likely to demonstrate grade-level reading by the end of third grade when compared to those that did not participate.
