

## Indicator 11 Data Collection Instructions

October 15, 2025	Local educational agencies (LEAs)	Report FFY 25 initial evaluations exceeding timeline due dates in Quarter 1 (7/1/25-9/30/25)
November 7, 2025	All LEAs	Data submission window opens – Single Sign-On FFY 24 consents secured between 7/1/2024 and 6/30/2025
December 19, 2025	All LEAs	Data submission window for FFY 24 ends
January 15, 2026	LEAs	Report FFY 25 initial evaluations exceeding timeline due dates in Quarter 2 (10/1/25-12/31/25)
February 13, 2026	LEAs Systemic Noncompliance	Documentation of Correction of Systemic Noncompliance (FFY 24) due
April 15, 2026	LEAs	Report FFY 25 initial evaluations exceeding timeline due dates in Quarter 3 (1/1/26-3/31/26).
April 24, 2026	LEAs Individual Noncompliance	Documentation of Correction of Individual Noncompliance FFY 24 due
July 15, 2026	LEAs	Report initial evaluations exceeding timeline due dates in Quarter 4 (4/1/26-6/30/2026)

### Indicator 11 (Initial Evaluation Timeline 60 Days)

#### FFY 25 Real-time reporting

1. LEAs are required to report all initial evaluations that exceeded the 60-day timeline during the current school year (FFY 25) by specific quarters.
2. Initial evaluations exceeding timeline due dates falling within the specified quarters (i.e., Quarter 1 dates 7/1/2025-9/30/2025) must be reported by the corresponding deadline (i.e., Quarter 1 due 10/17/2025). A list including the student's name, identification number, consent date, evaluation completion date, and reason for the delay, organized by the number of days exceeding the timeline (i.e., 10 days beyond, 11-20 days beyond, and 21 or more days beyond), must be uploaded to the district-specific Indicator 11 ShareFile folder.
3. Refer to the schedule for specified quarters and due dates.

#### FFY 24 Data Collection

All LEAs will submit Indicator 11 data for FFY 24

- Consents received between 7/1/2024 and 6/30/2025 will be submitted via Single Sign-On (SSO).
- Data submission window: between 11/7/2025 and 12/19/2025.

## Indicator 11 Data Collection Instructions

- *(Correction of Systemic Noncompliance)* LEAs below the Individuals with Disabilities Education Act (IDEA) target of 100% will need to submit a list of all evaluations exceeding the 60-day timeline. A list including the student's name, identification number, consent date, evaluation completion date, and reason for the delay, organized by the number of days exceeding the timeline (i.e., 10 days beyond, 11-20 days beyond, and 21 or more days beyond), must be uploaded to the district-specific Indicator 11 ShareFile folder by **February 10, 2026**.
- *(Correction of Individual Noncompliance)*. LEAs with initial evaluations pending completion by the close of the data submission window for FFY 24 (12/19/2025) must provide a list of student names, the date consent was obtained, the projected date of evaluation completion, and a reason for the delay by **April 24, 2026**. The documentation of individual noncompliance should be uploaded to the district-specific Indicator 11 Sharefile folder.
