PROGRAM DESCRIPTION

2.1 This section is the **executive summary** of this notice of intent. Tallahassee State College (TSC) proposes a **Bachelor of Applied Science (BAS) degree in Audit and Compliance Management** to address the growing demand for professionals in this field within our service district. As the capital of Florida, Tallahassee is home to numerous state and federal government offices, as well as public sector agencies, creating a significant need for experts in audit, regulatory compliance, and risk management.

The program aims to fill a critical gap in the workforce. The Florida Department of Commerce lists this occupation on the **regional demand list for 2024-2025**. This is also categorized as a high skill, high wage occupation. Local economic development initiatives and the expansion of Tallahassee's infrastructure, technology, and commercial real estate sectors further underscore the demand for graduates with expertise in compliance and auditing.

Primary pathways for admission include Associate in Arts (AA) and Associate in Science (AS) degrees, with a specific pathway from the Accounting Technology AS program. The curriculum will focus on developing skills in **internal control systems, fiscal responsibility, regulatory compliance, and auditing practices**. The program will also offer hands-on learning opportunities through **case studies, internships, and project-based assignments**.

Graduates will be well-positioned for career opportunities in government agencies, public sector organizations, and private businesses. Potential roles include **internal auditors**, **compliance officers**, **risk management specialists**, **and financial analysts**. Graduates can expect stable jobs in the government sector and related industries with salary projections approximately **\$50,000** according to the **Florida Department of Commerce**.

The BAS in Audit and Compliance Management is set to launch in August 2025, offering both face-to-face and online learning options to accommodate student needs. This program will play a crucial role in supporting Tallahassee's economic growth while ensuring fiscal responsibility and regulatory compliance across various sectors.

Based on the current needs of the community, there is an unmet need of 344 job openings. Florida State University and Florida A&M University do not offer a degree in audit and compliance management. Offering the B.S. program at TSC will meet the local unmet need by providing a talent pipeline of students trained in the auditing and compliance field. Additionally, many of TSC graduates are local to the region and Tallahassee is their home. They stay and work in the local region whereas students from FSU and FAMU are not local and usually do not remain in the local area after degree completion.

Tallahassee, as the capital of Florida, is home to numerous state and federal government offices, as well as public sector agencies. These institutions often require professionals with expertise in audit, regulatory compliance, and risk management. The Florida state government, one of the largest employers in the region, has many departments that need to ensure adherence to regulations, implement financial transparency, and conduct internal audits. Local employers would benefit from having a pool of trained professionals ready to address challenges related to legal regulations, internal audits, and financial accountability. Furthermore, the Florida Department of Commerce and organizations like the Greater Tallahassee Chamber of Commerce have laid out plans to foster sustainable economic growth, meaning more regulations, grants, and investments that need diligent auditing. Graduates of an Audit and Compliance degree program would be well-positioned to help ensure accountability in the distribution and use of economic resources for these initiatives.

Students who graduate with an A.A. degree or A.S. degree would matriculate into the BAS program as a career pathway. Students from a regionally accredited institution would also be able to enroll and complete the BAS. There are several employment opportunities in government or business.

After completing the B.A.S. in Audit and Compliance Management, graduates are well-prepared for the following:

- Auditor
- Compliance Officer
- Compliance Manager

Many individuals who are currently employed in state government, but have not obtained a bachelor's degree will also seek opportunities to obtain a bachelors degree. This will allow these individuals to advance within their organizations. This falls within Tallahassee State College's commitment to economic mobility.
